One of the relief opportunities offered by the Coronavirus Aid, Relief, and Economic Security Act (CARES) Act includes the Paycheck Protection Program. This program is a Small Business Administration (SBA) loan designed to help organizations, including community behavioral health providers that receive Medicaid funding, keep their workforce employed during the COVID-19 crisis.

The Office of Mental Health (OMH) wants to ensure that all providers are aware of potential funding opportunities. **The SBA has resumed accepting Paycheck Protection Program applications from participating lenders as of Monday, April 27, 2020, at 10:30 a.m. EDT.**
